

President's Foreword

Rhagair y Llywydd

It hardly seems ten years ago that the Welsh Centre for International Affairs was founded, and now I am writing my concluding Foreword upon my retirement as President on the Centre's Tenth Anniversary.

I have been privileged to preside over the birth of an exciting new institution, Wales' Window onto the World.

We have created a Centre unique in its field in the extent of its support from a wide cross-section of national institutions and interests. We have set a lead which many in other countries of the United Kingdom would very much like to follow.

In its first decade the Welsh Centre has:

- served as a co-ordinating and administrative centre for international campaigns in Wales
- made over 1,000 visits to schools, and given 50,000 children an insight into international affairs through projects, competitions, conferences, talks and curriculum development
- organised voluntary workcamps in local communities in Wales for hundreds of young people from many countries of the world
- * placed 60 British volunteers overseas each year
- raised over £120,000 during International Year of the Child 1979 and during International Year of Disabled People 1981 to support the work of the U.N. Children's Fund (UNICEF)
- * formed practical links with international agencies such as the United Nations, the EEC and the Commonwealth and hosted three major UN Conferences for the United Kingdom
- * provided the headquarters for the UK Freedom from Hunger Campaign
- instituted a Standing Conference for over thirty local authorities and a cross-section of national institutions
- published special studies of important international issues

All this would not have been possible without the dedication of my fellow Officers, the Director and his staff at the Temple of Peace, the members of the Co-Ordinating Committee and of the Standing Conference including Welsh Local Authorities and the hundreds of others who have helped by making financial contributions, by speaking at Conferences, by organising meetings, by serving on Committees and in many other different ways.

May I wish my successor and the Centre well as its second decade begins.

Message from the Director-General of UNESCO

The preamble to Unesco's Constitution, now signed and ratified by 159 Member States, begins with the words: 'Since wars begin in the minds of men, it is in the minds of men that the defences of peace must be constructed'. In the 37 years since Unesco came into being, when the Constitution was accepted by Greece, the 20th State to do so, the world has changed profoundly.

The structural changes that have occurred since 1946 have led to a world in which sources of friction are on the increase, just as the reasons for co-operating are becoming stronger. Unesco has always striven towards the establishment of peace through the development of communities and nations, the respect of peoples and human rights.

Mankind is becoming more and more interdependent, but human affairs are still not managed so as to meet the demands of human solidarity - the only sure shield against the menace of planetary destruction.

The Welsh Centre for International Affairs has, for the past few years, contributed substantially to the promotion of these objectives, through its stimulating programmes of meetings and debates on issues of peace, war and disarmament. For those people in Wales who have the power of decision-making and are in a position to spread information, these programmes have introduced new arguments and concepts into their reflection on international understanding and world problems.

I am pleased, on the occasion of the 10th anniversary of the Welsh Centre for International Affairs, to express my gratitude for its support of Unesco's aims and objectives, as well as my appreciation for its valuable contribution towards a world of peace, justice and freedom.

The Ninth Anniversary

Douglas Hurd MP, Minister of State at the Foreign and Commonwealth Office, was the guest speaker at the WCIA's Ninth Anniversary meeting at the Temple of Peace on October 15 on the 'UN Second Special Session on Disarmament and its Aftermath' (in conjunction with UNESCO).

A full hall heard a vigorous exposition of British policy matched by equally vigorous questioning from the floor.

The Chairman was the President of the WCIA Hon Edward Davies. (Copies of Mr Hurd's address are available on request: 50p including p&p.)

The Defence and Security Debate

1982-3 has been dominated by the continuing debate on defence and security and this was reflected in the programme of the Welsh Centre.

The highlights were the visits to the Temple of Peace of the Shadow Foreign Secretary, Denis Healey MP on May 12 and of the Secretary of State for Defence, Michael Heseltine MP on July 14.

Mr. Healey said: 'What the world now desperately needs is a halt to all new nuclear weapons' development and deployment as the first step to big reductions'.

'In the field of strategic weapons these reductions will produce greater stability only if they concentrate on weapons which threaten the other side's ability to strike back on the weapons which are most vulnerable, namely the MIRVed ICMBs on both sides.'

'The European balance could be stabilised by a ban on Cruise and Pershing II, with a reduction in SS20 warheads to the number of warheads already carried by the mainly sea-based intermediate range forces committed to NATO by the United States and Britain and of France.'

Mr. Heseltine said that the Soviets are maintaining a level of military force which went far beyond the requirements of self-defence. NATO was the only realistic counter to the threat we face. A non-nuclear policy which would have struck at the very heart of NATO was decisively rejected by the British Electorate in July.

'The agenda for peace is comprehensive. In the START talks the Alliance proposes a reduction in warheads on strategic ballistic missiles to 5,000 on each side; a reduction of about one third from present levels. In the INF talks the Alliance has proposed the zero option but has indicated that it is prepared to consider a reasonable interim settlement based on equal numbers of warheads. In MBFR the Western proposals would reduce the number of forces stationed within the MBFR guidelines area to 900,000 on each side. Finally, in March, Britain tabled the latest in the series of initiatives designed to achieve a complete and global ban on chemical weapons.'

In addition meetings were held at the Temple of Peace, October 2 (see page 13), Llandudno, November 27 (page 14), Cwmbran, May 13 (page 15) and Bridgend, May 27 (page 6).

Emeritus Professor Ieuan John wrote a special discussion paper on the pros and cons of 'No First Use of Nuclear Weapons' for the Winter 1983 Newsletter, and the Welsh Centre Special Paper No. 9, 'The Fiasco of Detente' by Goronwy J Jones, published in 1982 provided a general background for the whole discussion.

Young People's Activities

These are mainly concentrated on the work of the Council for Education in World Citizenship - Cymru (CEWC-Cymru) in the schools and colleges, and amongst industrial apprentices (see pages 28 and 29) and UN Association International Service.

CEWC Highlights

A number of notable activities of national importance organised by CEWC-Cymru took place this year.

The National Residential Sixth Form Conference 'Peace and Progress : Today's Challenge for the United Nations', Coleg Harlech, Gwynedd, April 12-16, 1983. The Conference was a great success. The 70 students from all parts of Wales remarked in particular about the high and interesting standard of the programme and the conference organisation, co-ordinated by Mrs. Alison Heard, Assistant Secretary, CEWC-Cymru. Lectures were given by distinguished speakers, including Sir Arthur Davies, Secretary-General Emeritus of the UN World Meteorological Organisation, Mr. Gary Fullerton of the UN Educational Scientific and Cultural Organisation (UNESCO), Mr. Keith Best MP (Treasurer, Inter-Parliamentary group for World Government) and Professor John Garnett (University College, Aberystwyth). A special debate on disarmament was also held with Rev. Owen Hardwicke and Councillor Frank Evans as the main speakers. An interesting feature of the programme was a simulation exercise about the UN General Assembly and a mock debate on border tensions between Venezuela and Guyana. Development issues were raised in another participatory exercise, the Trade Game, led by Mr. David Griffiths of Swansea and in a talk on 'Real Aid' by Mr. Elfed Jones of Oxfam, Wales.

The Conference was well supported by the local authorities, who sponsored sixtyone places. Support was also kindly given by the Standing Conference on Education for International Understanding (SCEIU), the Freedom from Hunger Campaign, UK Committee, the St. Davids Community, the UNA (Welsh Centre) Trust and the Dinam Charity.

The 'AO' Level in World Development. Since the 'AO' Level was introduced into the Welsh Joint Education Committee's examinations system last summer, considerable activity has taken place in promoting the syllabus.

Two schools, Ysgol Y Gader, Dolgellau and Ysgol Friars, Bangor and Aston College, Wrexham, of the North East Wales Institute of Higher Education, have taken this year's first examination as a trial run, entering approximately 60 candidates.

Their experiences have been invaluable for other interested teachers and educationalists. Two teachers day-workshops have taken place: in Swansea, on March 3 and in Bangor on July 12. Mrs. Heard prepared a report describing their findings and produced a revised Course Bibliography, now available in printed form. To establish further the syllabus within the formal sector, several conferences were organised last October with the Education Advisers of each Authority in Wales. Subsequently a number of the Advisers have been very supportive of 'AO' Level meetings planned for schools.

It is therefore most promising that after one year, over twenty schools have decided to take up the syllabus for the second examination in 1984. Workshops have already been organised by Mrs. Heard for teachers to work on resources, teaching materials and ideas. It is also interesting to note that following publication of the 'AO' Level news in various journals and papers, including the UN Development Forum, inquiries have come from as far afield as Mauritius, Turkey, Ireland and Canada, as well as from many schools in England.

National Conference for Primary Teachers on Development Education 'It's Our World', Llandrindod Wells, November 1982. This was an attempt to introduce development education to the primary teachers of Wales. There were sixty participants from seven of the eight counties, including teachers, advisers, college lecturers and students of education. Guest speakers included Dame Margaret Miles, Mr. Roy Williams of the Schools Council, Mr. David Hicks and Mr. Simon Fisher of the Eight to Thirteen Project. Workshop activities were led by Mrs. Heard, Rev. Tom Evans (Christian Aid), Mr. Elfed Jones (Oxfam) and Mr. Gareth Wheatley (N.E. Wales Institute of Higher Education).

The aims of the Conference were to introduce the philosophy of and background to education for international understanding, to introduce and demonstrate the Schools Council/Rowntree World Studies Eight to Thirteen Project and to illustrate the Project's ideas on 'Getting on with Others' and 'Looking to the Future' and also to assist LEA's and teachers to put the ideas into practice.

Several initiatives were subsequently undertaken, particularly in West Glamorgan, Clwyd and Gwynedd. It has also encouraged Gwent, Mid and South Glamorgan to include speakers and further resources in the annual in-service programme for teachers.

International Service Highlights.

The programme this year consisted of 12 Camps.130 volunteers came to Wales from 17 countries: England, France, Italy, Germany, Ireland, Holland, Denmark, Switzerland, Belgium, Spain, Portugal, Morocco, Turkey, Czechoslovakia, Hungary, USA and Canada.

UK volunteers were also sent to camps abroad. 85 volunteers went to France, Germany, Eire, Canada, Holland, Denmark, Switzerland, Belgium, Spain, Hungary, Czechoslovakia, Turkey, Morocco and Portugal. Two volunteers were accepted on a camp in Gdansk, Poland in August. They stayed at a student hostel working on various projects in the area.

Every year the number of enquiries from young people eager to participate in the Workcamps programme increases and we would like to extend our programme in North, Mid and West Wales to help meet this demand. We would ask those associated with the Welsh Centre in these parts of Wales to help us to find sponsors for our camps.

Tenth Anniversary Appeal - 1983 Target - £100,000

Viscount Tonypandy (the former Speaker of the House of Commons, Rt. Hon. George Thomas MP) is the Chairman of the National Appeals Committee, with Dr. T.P. Jones as National Co-ordinator. The South Wales Chairman is Mr. AubreyJones, and North Wales, Lady Goronwy-Roberts. The Secretary is the Assistant Director of the Welsh Centre, Mrs. Rayner Rosser.

Through the hard work of the Committee and the generosity of supporters £31,500 was raised by August 31, comprising £11,500 in capital amounts and £20,000 in grossed-up covenants.

Further events are being planned for the remainder of the year. We appeal to all supporters to help us in any way that they can.

Finance

Excluding special designated funds of £1,808, £158,333 was held in the UNA (Welsh Centre) Trust at the close of its financial year on 31 December, 1982. Interest of some £20,000 helped to meet some of the core costs of the Centre so far as its charitable activities were concerned. While such reserves may seem at first sight healthy, the interest represents virtually all the assured income that the Trust has. If grants which are usually made on an annual basis were to cease, the lack of such reserves would mean the dismemberment of the Centre.

Each member organisation of the Co-ordinating Committee makes a contribution of £25 annually to the Welsh Centre for International Affairs account, which at 31 August, 1983 stood at £176 after a loan of £5,000 to the UNA (Welsh Centre) Trust. A proportion of the costs of the Annual Report was met from this account. For information, there is appended a summary of the Trust Accounts.

LEGACIES AND GIFTS

Gifts made during life or by will to a Charity are exempt from Capital Transfer Tax. Anyone kindly minded to benefit the Trust in this way should seek the advice of his or her solicitor on the substantial benefits involved.

COVENANTS

The Finance Act 1980 made new provisions with regard to gifts to charities in the form of a deed of covenant. Individuals can, in addition to receiving income tax relief at the basic rate of 30% obtain relief at higher rates of income tax which they may be paying and the investment income surcharge in respect of payments made on or after 6 April 1981. The amount relieved against the higher rates of income tax and investment income surcharge is limited to a maximum of £3,000 per annum. Your accountant would clarify any difficulties.

The Quest for Human Rights

The Welsh Centre held its second Conference in conjunction with the Council of Europe, Strasbourg at the Temple of Peace on November 12 on the 'European Convention of Human Rights, the European Commission and the European Court.'

It was directed particularly at practising lawyers, barristers and solicitors who might be called upon to advise clients who wished to bring applications before the Commission. The speakers included, Sir Vincent Evans, British Judge on the European Court of Human Rights on 'British Cases Before the Court', Dr. Frits Hondius, Deputy to the Director of Human Rights, 'The Council of Europe and Human Rights', Mr. Paul Mahoney, 'European Court of Human Rights, Proceedings before the European Court of Human Rights, Practice and Procedure', and Mr. J.P. Gardner, European Commission of Human Rights, 'Recent Trends in the Case Law of the European Commission of Human Rights'. The Chairman was Judge David Williams Q.C. The indications were that the gathering of 80 delegates found the occasion stimulating and helpful.

The Advisory Committee for Development Education and Information

The purpose of this committee is to co-ordinate the very considerable amount of work done in Wales so that duplication and overlap can be avoided and also to develop joint initiatives such as the 'AO' Level project, which was pioneered by CEWC-Cymru and the Development Resource Centre, the provision of a list of speakers in various parts of Wales on development issues and the completion of an annex for Wales for the UNESCO Sponsored Report on "Education at 16 plus" produced by the Standing Conference for Education in International Understanding in London.

In its implementation of these objectives the Committee covered the following issues during 1982-3: Primary, Secondary and Tertiary Education; the aftermath of the Brandt Report, British Aid Strategy, Initial Training and IN-Service Training for Teachers; World Food Day; S4C and Overseas Development Programmes; the Wrexham-Maelor Local Authority Initiative by the NE Wales Institute for Higher Education; Development Education and the Government; the compilation of a Register of Speakers.

Members include: Mr. John Beale, Director of Education, West Glamorgan County Council; Miss Ann Davies, Secretary, Wales Young Farmer's Clubs; Mrs. Marian Fairman, Welsh National Centre for Religious Education, Bangor; Mrs. Alison Heard, Assistant Secretary, CEWC-Cymru; Mr. Elfed Jones, Oxfam; Dame Margaret Miles, formerly Chairman ACDE; Mr. Ronwy Rogers, Council of Churches for Wales; County Councillor R.E. Roberts, WJEC; Mr. Eirwyn Thomas, HM Inspectorate, Welsh Office; Professor Wyn Vittle, Christian Aid; Mr. Gareth Wheatley, North E Wales Institute of Higher Education. The Chairman is Professor Glyn O Phillips, Principal, North E Wales Institute of Higher Education and the Chairman of CEWC-Cymru. The Secretary is the Director of Welsh Centre.

Special Papers

It was the intention to produce a Special Paper outlining the policies of the political parties on defence and security issues as background to a series of planned pre-election meetings involving representatives of the parties. The early calling of the election negated this.

Two comprehensive discussion papers were produced during the year which were sent out with the Winter and Summer Newsletters. The first by Emeritus Professor leuan John of Aberystwyth considered: 'Raising the Nuclear Threshold: the case for and against a Western Adoption of a 'No first use of Nuclear Weapons'. The second by Dr. Rose D'Sa, University College, Cardiff discussed 'Brandt II - Blueprint for World Recovery. Can it Succeed?'

The Information/Resource Centre

Since the appointment of an Information Officer in April 1983 under a MSC project, the task of developing and expanding the Information/Resource Centre has been undertaken. The aim of the Centre is to provide information of a comprehensive nature on a variety of subjects concerned with international affairs, the Third World and development in general. Some of the literature is free. Interested parties are welcome to come to the Centre and use the resources for their own private study. The Centre will help to extend the service already offered to schools interested in the 'AO' Level: World Development Project.

The Centre also provides back-up exhibitions for the work of the Welsh Centre.

Register of Speakers

The Welsh Centre together with the Advisory Committee for Development Education has compiled a Register of Speakers of people throughout Wales, who are prepared to speak on a variety of subjects connected with development education. The Register is available from the Welsh Centre for 35p including postage and packing.

The World Studies Training Centre, at the University of York, is undertaking the compilation of a register of speakers on Development/Global Issues for the United Kingdom. The list of speakers in Wales in the U.K. register has been supplied by the Welsh Centre, the work having been co-ordinated from Cardiff by its Advisory Committee on Development Education and Information.

Publications and Press Cuttings

The Welsh Centre regularly receives over 60 publications and reports on all aspects of international affairs from the United Nations, regional organisations and from other sources. A press-cuttings service is maintained under the following headings: Europe; the Americas; the Communist bloc; Asia; Middle East; Africa; Disarmament; Development and Trade; Environment; United Nations; Domestic.

Unesco in Wales

UNESCO is the United Nations Educational, Scientific and Cultural Organisation, one of the specialised agencies of the United Nations family. Created in 1946, it is an inter-governmental agency made up of 146 member States.

The purpose of the organisation, as defined in its Constitution, is 'to contribute to peace and security by promoting collaboration among the nations through education, science and culture in order to further universal respect for justice, for the rule of law and for the human rights and fundamental freedoms which are affirmed for the peoples of the world, without distinction of race, sex, language or religion, by the Charter of the United Nations'.

Since a visit by Mr W R Davies, the Director, to UNESCO's Headquarters in Paris in 1980, a close relationship has developed between the two organisations. This is highlighted by a message from the Director-General of UNESCO, Mr Amadou-Mahtar M'Bow, in this 10th Anniversary Report.

The personal representative of Mr M'Bow, Mr Gary Fullerton, spoke at the National Residential 6th Form Conference at Harlech in April. In 1982, UNESCO was associated with Conferences of the Centre in Cardiff, Llandudno, Cwmbran and Bridgend in line with UNESCO's medium-term plan for peace. There were UNESCO exhibitions and UNESCO publications and pamphlets were made available. There was also a UNESCO section in the Resource Centre at the Welsh Centre, while the Council for Education in World Citizenship-Cymru promotes the ideals of UNESCO in its work in the schools in Wales. All this compliments the collaboration with the Annual Anniversary Meeting.

The United Kingdom Freedom From Hunger Campaign

The FFHC Committee, administered from the Welsh Centre, is supporting four main projects; two in India, one with the Bihar State Dairy Corporation, to set up a dairy in Muzaffarpur (£317,000), which was inaugurated on 12 March 1982 and the other a cattle improvement scheme with the Pradesh Dairy Co-operative Federation, Uttar Pradesh (£118,000); one in Malawi to develop a Nutrition Training Unit at Bunda College, which was completed in 1982 (£87,000); and water-drilling with Family Farms, Zambia (£51,000).

The Committee has also supported the educational work of the Centre for World Development Education (CWDE) London, and the Council for Education in World Citizenship - Cymru (CEWC-Cymru).

Unicef

A feature of the fund-raising programme for UNICEF during 1982-83 has been the involvement of various organisations and individuals. Allders, the Cardiff Department Store, performed the first of what will be an annual Fashion Show on September 22. As entrants in our Award Scheme for UNICEF, Theatre Powys and the Gwent Theatre in Education both gave performances and the proceeds of their collections for UNICEF. The Cwmbran Slimming Club, the Bridgend Council of Churches, branches of UNA and other organisations have also participated by holding fund-raising events.

There were special Emergency Appeals in the Lebanon and Ethiopia which were well supported, and well publicised by the media.

The Welsh Centre Volunteer Network was started in May at the Temple of Peace. Twenty volunteers raise funds for UNICEF and also support the work of the Welsh Centre by helping at special events or at headquarters.

UNICEF Christmas cards were on sale at the Centre last year. Over £2,000 was raised to benefit UNICEF's funds.

Reports of Organisations Represented on the Co-ordinating Committee

The Organisations represented on the Co-ordinating Committee have made important contributions to the activities of the Welsh Centre, but it has not been felt necessary to refer to them specifically in each case. Summaries of their Reports are available on request.

(a) United Nations Association, Welsh National Council Annual General Meeting. The 37th AGM was held at the Temple of Peace on Saturday, March 26. Mr. William Davies (Cwmbran) and Mr. R. Palmer (Cardiff) were re-elected President and Hon. Treasurer respectively. At a subsequent Executive meeting, Mr. Alwyn Evans (Swansea) was elected Chairman, succeeding Mr. Goronwy Jones (Bridgend) who retired after three years in office. The following were (re) elected to serve on the Executive Committee 1983-6: Prof. leuan John, Mr. Malcolm Pill Q.C., Cllr. H.J.B. Watkins, Mr David Knox. And the following were co-opted for 1983-4: Mrs. V. Smith, Mr. Alun Griffiths, Mr. Michael Gwyther, Prof. H. Hearder, Mr. Ifor James, Mr. Allan Jones, Mr. M.J. Jones, Mr. M. Williams, Mr. M. Peterson, Mrs. S.E. Charles.

Policy Developments. Issues discussed during the year included Disarmament and Security, British Aid Policy, Chile, the UN and Human Rights, the Law of the Sea, Strengthening the UN, the Bahai's in Iran. A resolution was forwarded to the AGM of the General Council of the UN Association of Great Britain and Northern Ireland at Leeds in April asking her Majesty's Government to restore the Development Education Fund, which was approved by the whole gathering.

Womens Advisory Council. During the year the Council participated on October 2 in the Conference on the UN Special Sesssion on Disarmament addressed by Miss Brigid Fitzgerald of UK UNA; was addressed on November 6 by Mr. William Davies, President WNC of UNA on 'Is UNA Worthwhile?'; was addressed on July 22 by Mrs Ruth Osborn of the Women's International League for Peace and Freedom. At the AGM on May 7 Mrs. V.L. Smith was elected chairman in succession to Mrs. M. Bold and Miss P.R. Hill succeeded Mrs. Smith as Secretary, Mrs. Bold and Mrs P. Harrison-Roderick became vice-chairman.

Membership. At the close of 1982, membership stood at 742 a decrease of 12 on 1981.

Constituency Plan. Mr. Tony Cheney and later Mr. Michael Peterson served as Development Officers under a one year MSC scheme during the year. Both were to find permanent employment which gave pleasure to members of the Committee. Attempts to find Parliamentary Constituency representatives ran into the difficulty that individuals interested in the project were too heavily committed to their respective political parties to have much time for another initiative.

Curriculum Development in Development Education. Significant progress has been made both at an 'AO' Level and in the primary sector (see page 17)

Schools Conferences and Meetings:

Gwent Sixth Form Conference 'Present Day Conflicts and Tensions' Croesyceiliog Comprehensive School, October 22. 160 sixth formers from Gwent schools attended. Speakers included Professor H. Hearder, University College Cardiff and Emeritus Professor U. Henriques, Cardiff.

Clwyd Sixth Form Conference, 'Aid and Trade', Theatr Clwyd, Mold November 20. 150 sixth formers participated. Guest speakers were Sir Anthony Meyer MP, Rev. Tom Evans (Christian Aid), Mr. Gareth Wheatley (NEWI) and Mr. Brian Pratt. EEC Sixth Form Residential Conference, University College, Cardiff December 13-15. A party was again organised for 150 Cardiff children. Through CEWC, a large number of sixth formers gave willing assistance on the day.

South and Mid Glamorgan United Nations Model Security Council Debate, Temple of Peace, March 4 (in conjunction with Cardiff UNA). Seventeen schools sent teams to this debate on the Middle East.

The Sallie Davies Memorial Competition. The competition was linked with the UNICEF Award Scheme, organised by the Welsh Centre. Participants were asked to design a creative piece of work promoting awareness of UNICEF in schools. The first prize of £100 was awarded to Llandrindod High School and the second prize £50, to Cardigan County Secondary School.

School Visits. In addition to the School Conferences, meetings and 'AO' Level work, Mrs. Heard visited sixty schools this year, giving talks and maintaining personal contacts with staff and pupils.


