the Honourable Sir George Bellamy Knight Commander of the Royal Victorian Order,
Garter Principal King of Arms, Sir John Duranach Seaton Amstrong,
Knight Member of the Royal Victorian Order, Clarencieux King of Arms
and Sir Gerald Woods Hellier Knight Commander of the Most Honourable Order of the Bath, Knight Commander of the Royal Victorian Order
of the Garter and Ulster King of Arms send greeting.

Whereas —

Charles Alfred Mace Esquire Chairman of the Rural District Council of Cowbridge in the County of Glamorgan hath presented unto The Most Noble Bernard Marquess Duke of Norfolk Knight of the Most Noble Order of the Garter Knight Grand Cross of the Royal Victorian Order, Earl Marshal and Hereditary Marshal of England and one of Her Majesty's Most Honourable Privy Council that the said Council was duly constituted under the Local Government Act 1894 and that the Councillors of the said Rural District Council are desirous of having Aimeral Bearings duly assigned with lawful authority and he hath requested the favour of His Grace's Warrant for granting and assigning such Aimeral Bearings as may be proper to be borne and used by the Rural District Council of Cowbridge on Seals Shields or otherwise according to the Laws of Arms. And forasmuch as the said Earl Marshal did by Warrant under his hand and Seal bearing date the Tenth day of December 1954 authorize and direct us to grant and assign such Aimeral Bearings accordingly Know ye therefore that we the said Garter Clarencieux and Ulster in pursuance of His Grace's

Warrant and by virtue of the Letters Patent of Our several Offices to each of Us respectively granted do by these presents grant and assign unto the Rural District Council of Cowbridge the same following that is to say —

Sable the head of a Celtic Cross within an Oyle composed of eight Garbs and at the base a Cow's head caboshed Or. And for the Crest On a Heath Or and Vert In front of two Wings conjoined in base Or a Miner's Lamped Oil. And for the Mantling hereof more plainly depicted to be borne and used for ever hereafter by the proper as the same are the margin hereof more plainly depicted to be borne and used for ever hereafter by the Rural District Council of Cowbridge on Seals Shields or otherwise according to the Laws of Arms. In witness whereof the said Garter Clarencieux and Ulster Kings of Arms have to these Presents subscribed their names and affixed the Seals of Our several Offices this Sixteenth day of January in the Fourth year of the Reign of Our Sovereign Lady Elizabeth the Second by the Grace of God of the United Kingdom of Great Britain and Northern Ireland and of Her other Realms and Territories Queen Head of the Commonwealth Defender of the Faith and in the year of Our Lord One thousand nine hundred and fifty six.

The Armorial Bearings of the Rural District Council of Cowbridge

By Letters Patent dated 30th January 1956, the College of Arms has granted armorial bearings to the Cowbridge Rural District Council in the following terms:—

“Sable the head of a Celtic Cross within an Orle composed of eight Garbs and at the base a Cow's Head caboshed Or and for the Crest On a Wreath Or and Vert In front of two Wings conjoined in base Or a Miner's Lamp proper”.

The black shield represents heraldically the rich mineral deposits of coal, iron ore and limestone found throughout the Rural District, the Celtic Cross the early Christian establishments at Llantwit Major and Llangan and the Corn Sheaves and Cow's Head the rich dairy, arable and hill farming practised throughout the area.

Upon the shield rests the closed helm proper to civic arms, with its crest-wreath and decorative mantling in green and gold. Upon the wreath stands the crest, the two wings representing the Royal Air Force Stations within the District and the Miner's Lamp proper symbolising the mining activities carried out in the northern part of the area.

The Motto “A Fynno Duw a Fydd” being translated means “What God wills, shall be”.

The Display Cabinet for the Grant of Arms was made and presented by J. Stanley Morgan, Esq., Llanharan, Works Department Manager of the Council.

Chairman's Insignia


The Chairman's Jewel is in 9 ct. gold and hand painted enamels and displays the Armorial Bearings of the Council, pierced out and raised above the background.

The Chain is executed in similar gold and is made up of enamelled links which bear the initials C.R.D.C. alternating with a link which incorporates the Crest of the Armorial Bearings. On the reverse side of the links are engraved the names of twenty-eight parishes which make up the Cowbridge Rural District.

The fees in connection with the granting of the Armorial Bearings and the cost of providing the Chairman's Insignia were donated by public subscription. The Council wish to place on record its grateful thanks to all those who subscribed to the fund.

The Arms and Chairman's Jewel were designed at the College of Arms by Sir John D. Heaton Armstrong, M.V.O., Clarenceux, King of Arms.

The Chain of Office and the Chairman's Jewel were manufactured by Heraldry Today, 10, Beauchamp Place, London, S.W.3.
