# COMPULSORY ORDER.

---

## EDUCATION ACT, 1921 (SECTION 111).

---

The Glamorgan County Council as the Local Education Authority for the Borough and Parish of Cowbridge and the Parish of Llanblethian all in the County of Glamorgan hereby make the following Order :—

1 The Local Education Authority, for the purpose of their powers and duties under the Education Act 1921, and subject to the provisions of that Act, hereby put in force, as respects the leasehold and other interests in the premises described in the Schedule hereto, the provisions of the Lands Clauses Acts with respect to the purchase and taking of land otherwise than by Agreement.

2 For the purposes of Section III of the Education Act, 1921, this Order shall have effect as if there were incorporated therewith, subject to the necessary adaptations, the Lands Clauses Acts (except Section 127 of the Lands Clauses Consolidation Act, 1845) and Sections 77 to 85 of the Railways Clauses Consolidation Act, 1845, but subject to this modification, that any question of disputed compensation shall be determined in the manner provided by the Acquisition of Land (Assessment of Compensation) Act, 1919.

3 This Order may be cited as the Cowbridge Grammar School Order, 1925.
