Outside the South Gate, Cowbridge (including Rose Cottage, Poplars and Dynevor)

Rose Cottage, grade II listed (late 18th/early 19th century on line of town walls and adjacent to medieval town gate) – joined to the west side of the South Gate, outside the walls; the Butts garden relates to that land between Rose Cottage and the SW bastion of the town walls, lying outside the walls. In 1999, part is a macadamed car-park, the western part being used for the cattle market (officially on market days only).

The north west garden wall to Rose Cottage and the south west garden walls to Old Hall and the Grammar School garden at the south east are also Grade Il listed – as a structure preserving the historic line of the medieval town walls).

The Poplars an early 19th century house, is also Grade II listed – preserving its historic character.
