
It was indeed a pleasure to have the opportunity to spend time previewing our hotels which could accommodate your convention for 1992.

Greetings from the HYATT REGENCY CROWN CENTER!



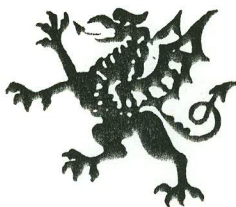
