

Dear Jack:

During the past couple of weeks Mike Brennan of the Sheraton Regional Office has been in close contact with me concerning your 1974 convention. Mike has informed me that, as yet, you have not reached a decision about a headquarter hotel.

I have reviewed your itinerary with Mike and feel that I am thoroughly familiar with your requirements. As I understand it, next years' meeting is a two-part meeting. There will be a group of people going to Wales for about a week, in addition, there will be a meeting in the United States lasting four or five days.

Jack, I have reviewed our availability of space, and unfortunately, all of Labor Day weekend is sold out. However, we would be able to offer the dates of August 24 thru 28, 1974. (The week immediately preceding Labor Day weekend). I realize that this would be a departure from your normal meeting dates over Labor Day weekend; however, I feel that it may offer some advantages.

We sincerely want your business and would be in a position to negotiate an extremely financial package during the above set of dates. In short, your people would be spending considerably less money than they might during the Labor Day weekend. Another advantage is that your membership would not be driving during the hazardous Labor Day weekend.

Since I do not believe this would affect the vacation time of those people going to Europe...it is my understanding that they would be attending the state side meeting as well.
