## **MEMORANDUM**

RE:	Treasurer's Report

Attached is a report covering the transactions to date. This reflects the total of all deposits less the total of all checks written. Major unpaid bills are: Central Lutheran and the expenses for the CD's and tapes. I have received the bank statement through October and in quickly trying to reconcile that with my records, I show more cash left than the bank shows. Also, the balance in my ledger does not reconcile with either amount. Using the balance shown by the bank at October 31 and deducting checks written since then, the surplus would be \$18,907.32. Rather than take the time to try to figure out why the amounts do not reconcile, I sent the bank statement and copies of my ledger to Mary Henry. Since she does a reconciliation every month, I thought I would wait to see if she could figure it out. Also, I presume she will probably be the one to work with Ellis to do the "audit" called for by the WNGGA constitution.

In previous reports I tried to compare income and expenditures with the budget. The information to do a comprehensive comparison is probably available at WNGGA's offices. However, I don't see the need for us to make the effort to develop that information, since I suspect it will be a few years before we do this again. I think it would be useful for the WNGGA to do a detailed review to help future venues do a better job with the budgeting process.

I have attached a copy of the ledger sheets showing all of the checks written to date, so everyone can see where the money went.
